CITY RESOLUTION NO. 064-2017

A RESOLUTION APPROVING BARANGAY RESOLUTION NO. 17, SERIES OF 2016 OF BARANGAY PALLUA NORTE TITLED “A RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD OF TUGUEGARAO CITY NAMING THE NO NAME STREET OF PALLUA NORTE LOCATED AT CITY ROAD, PALLUA NORTE, TUGUEGARAO CITY INTO BLAS MALLILLIN STREET”

WHEREAS, Section 13 (c) of the Local Government Code provides that “*The Sanggunians of component Cities and Municipalities, may, in consultation with the Philippine Historical Commission, change the name of city, municipal and barangay roads, avenues, boulevards, thoroughfares and bridges*”;

WHEREAS, on September 24, 2016, the Barangay Council of Pallua Norte, Tuguegarao City approved Resolution No. 17, series of 2016 titled “*A Resolution Requesting the Honorable Sangguniang Panlungsod of Tuguegarao City Naming the No Name Street of Pallua Norte Located at City Road, Pallua Norte, Tuguegarao City into Blas Mallillin Street*”;

WHEREAS, the said Barangay Resolution was endorsed to the Seventh City Council by the City Mayor, Hon. Atty. Jefferson P. Soriano;

WHEREAS, the Committee on Rules, Laws and Ethics has exhaustively studied the request and approved the same since it is in order, subject to the submission of an approved road plan.
