**CITY RESOLUTION NO. 067-2017**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR TO SIGN THE PERFORMANCE COMMITMENT FOR HEALTH CARE INSTITUTIONS (HCIs) OF THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)**

**WHEREAS**, the Tuguegarao City People's General Hospital is a duly registered/licensed/certified health care hospital capable of delivering the services expected from the type of health care provider;

**WHEREAS**, the Tuguegarao City People's General Hospital is managed by officers and employees who are members of good standing of the National Health Insurance Program (NHIP) who commit to comply with all pertinent laws, rules and regulations, policies, administrative orders and issuances;

**WHEREAS**, the Tuguegarao City People's General Hospital has established management information system ensuring access to vital information needed by Philippine Health Insurance Corporation (PhilHealth) in aid of monitoring and protecting the NHIP against abuse, violation and/or overutilization of its funds;

**WHEREAS**, the Local Government Unit of Tuguegarao City recognizes the NHIP as a partner in providing quality healthcare program to its constituents and improving lives by providing health insurance coverage and ensuring affordable, acceptable, available and accessible healthcare services;

**WHEREAS**, one of the requirements needed for the Tuguegarao City People's General Hospital to be accredited by the Philippine Health Insurance Corporation (PhilHealth) is the Performance Commitment duly signed by the City Mayor.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor to sign the Performance Commitment for Health Care Institutions (HCIs) of the Tuguegarao City People's General Hospital with the Philippine Health Insurance Corporation (PhilHealth).
