PAGULAYAN, JR., HEAD, INSTITUTE OF TRAFFIC MANAGEMENT, FOR THE PURPOSE OF ASSISTING THE CITY IN THE IMPLEMENTATION OF TRAFFIC MANAGEMENT

WHEREAS, pursuant to Civil Service Commission Memorandum Circular No. 21, series of 2002 by virtue of Civil Service Commission Resolution No. 02-1181 dated September 13, 2002, the Commission has adopted and promulgated the guidelines and policies governing the detail of employees from one department or agency to another;

WHEREAS, by virtue of that Memorandum Circular, the Local Government Unit of Tuguegarao is extending its desire to seek the expertise of a certain agency of the national government and this can only be achieved by requesting such agency to detail its personnel or employee in the locality;

WHEREAS, the Metropolitan Manila Development Authority (MMDA), whose main office is situated at Makati City, Philippines, is the agency which the Local Government Unit of Tuguegarao would like to seek technical assistance particularly in the aspect of traffic management;

WHEREAS, the preference needed by the LGU-Tuguegarao should preferably one who has the knowledge and experience in the field of traffic management, one who can speak and understand the local dialect of Tuguegarao and one who is familiar with the place;

WHEREAS, Mr. Antonio B. Pagulayan, Jr. is the proper and preferred personnel needed by the LGU considering his competency in the field of traffic and transport management as well as the preference afore-cited in the preceding;

WHEREAS, the compensation, benefit and other emoluments of Mr. Antonio B. Pagulayan, Jr. during his deployment in the LGU-Tuguegarao shall be shouldered by the MMDA, as per interpretation under CSC Memorandum Circular No. 21, series of 2002, however, the LGU, if pertinent laws allow, will provide or grant him allowance as a counterpart.

RESOLVED, as it is hereby **RESOLVED**, to request the Hon. Thomas S. Orbos, OIC Chairman/General Manager, Metropolitan Manila Development Authority (MMDA), to detail in the Local Government Unit of Tuguegarao City the person and services of Mr. Antonio B. Pagulayan, Jr., Head, Institute of Traffic Management, for the purpose of assisting the City in the implementation of traffic management.

RESOLVED FINALLY, that a copy of this resolution be forwarded to the Office of the City Mayor, Hon. Bienvenido C. De Guzman II, and to the Office of Hon. Thomas S. Orbos, OIC Chairman/General Manager, Metropolitan Manila Development Authority (MMDA), Makati City, Philippines, for their information and consideration.


With eight (8) members voting in favor, two (2) against (Hon. Maila Rosario T. Que and Hon. Mary Marjorie P. Martin-Chan) and one (1) abstention (Hon. Anthony C. Tuddao), **CITY RESOLUTION NO. 071-2017** was **APPROVED** under suspended rules.
