A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AND/OR OIC-LEGAL OFFICE, ATTY. LOUIE BERNARD C. AQUINO, AND/OR CITY LEGAL OFFICER AND OIC-CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO), ATTY. NOEL A MORA, TO REPRESENT TUGUEGARAO CITY GOVERNMENT IN CIVIL CASE NO. 8392 TITLED BANGKO SENTRAL NG PILIPINAS VERSUS TUGUEGARAO CITY PENDING BEFORE THE REGIONAL TRIAL COURT, BRANCH 2, TUGUEGARAO CITY”

WHEREAS, Tuguegarao City Government is an entity duly created under the laws of the Republic of the Philippines;

WHEREAS, under Article 1, Section 3 of Republic Act No. 8755, Tuguegarao City Government has the right to sue and be sued as a government entity. It is hereby represented by its City Mayor, Hon. Bienvenido C. De Guzman II, and/or OIC-City Legal Office, Atty. Louie Bernard C. Aquino, and/or City Legal Officer and OIC-City Environment and Natural Resources Office (CENRO), Atty. Noel A. Mora;

WHEREAS, for the protection and enforcement of the rights and interests of Tuguegarao City, there is a need for the City Mayor, Hon. Bienvenido C. De Guzman II, and/or OIC-City Legal Office, Atty. Louie Bernard C. Aquino, and/or City Legal Officer and OIC-City Environment and Natural Resources Office (CENRO), Atty. Noel A. Mora, to be authorized to represent Tuguegarao City in Civil Case No. 8392 titled Bangko Sentral ng Pilipinas versus Tuguegarao City pending before the Regional Trial Court, Branch 2, Tuguegarao City;

WHEREAS, City Mayor, Hon. Bienvenido C. De Guzman II, and/or OIC-City Legal Office, Atty. Louie Bernard C. Aquino, and/or City Legal Officer and OIC-City Environment and Natural Resources Office (CENRO), Atty. Noel A. Mora, are also authorized to represent the Tuguegarao City Government in all stages of the proceedings like mediation, preliminary conference, pre-trial to discuss the matters stated in Section 2, Rule 18 of the Rules on Civil Procedure, trial by presenting evidence in its behalf and appeal for the review of Civil Case No. 8392 titled Bangko Sentral ng Pilipinas versus Tuguegarao City pending before the Regional Trial Court, Branch 2, Tuguegarao City;

WHEREAS, City Mayor, Hon. Bienvenido C. De Guzman II, and/or OIC-City Legal Office, Atty. Louie Bernard C. Aquino, and/or City Legal Officer and OIC-City Environment and Natural Resources Office (CENRO), Atty. Noel A. Mora, are likewise authorized to enter into amicable settlement and enter into compromise agreement under such terms and conditions they may deem just and equitable under the circumstances, to submit to alternative modes of dispute resolution and to enter into stipulation or admission of facts and documents to manifest its intention to avail itself of discovery procedure or referral to commissioners;

RESOLVED FURTHER, that City Mayor, Hon. Bienvenido C. De Guzman II, and/or OIC-City Legal Office, Atty. Louie Bernard C. Aquino, and/or City Legal Officer and OIC-City Environment and Natural Resources Office (CENRO), Atty. Noel A. Mora, shall be authorized to enter into a compromise agreement with the Bangko Sentral ng Pilipinas subject to the approval of the Sangguniang Panlungsod of Tuguegarao.
