RESOLUTION REQUESTING THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), REGIONAL OFFICE 02, TUGUEGARAO CITY THROUGH ITS REGIONAL VICE PRESIDENT, MR. OSCAR ABADU, TO ASSIGN AND MAINTAIN A PHILHEALTH PERSONNEL AT THE TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL (TCPGH) TO ASSIST AND PROCESS CLAIMS OF PHILHEALTH

WHEREAS, the personnel assigned to the People’s General Hospital were recalled by the Philippine Health Insurance Corporation (Philhealth) due to an ongoing investigation on Philhealth claims;

WHEREAS, as a consequence of the said recall, the services offered by the People’s General Hospital were greatly affected causing some problems on the patients of Tuguegarao City on Philhealth matters;

WHEREAS, in order to solve the matter, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to pass a resolution for the herein purpose;

WHEREAS, after a discussion on the said request, the Seventh City Council during their 30th Regular Session deemed it necessary, proper and urgent to pass the said resolution.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to request the Philippine Health Insurance Corporation (PHILHEALTH), Regional Office 02, Tuguegarao City through its Regional Vice President, Mr. Oscar Abadu, to assign and maintain a Philhealth personnel at the Tuguegarao City People’s General Hospital (TCPGH) to assist and process claims of Philhealth.

RESOLVED FURTHER, to furnish a copy of this resolution to the Philippine Health Insurance Corporation (Philhealth) for information and proper action.


