CITY RESOLUTION NO. 094-2017

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) FOR THE GRANT OF TEN (10) FISHING STALLS TO TEN (10) CONSTITUENTS OF TUGUEGARAO CITY

WHEREAS, in line with the objectives of the Bureau of Fisheries and Aquatic Resources (BFAR) to increase the fisher folks' production and profitability, it shall grant ten (10) Fishing Stalls to ten (10) constituents of Tuguegarao City;

WHEREAS, in order to ensure the successful distribution and preservation of the Fishing Stalls to the recipients, there is a need for the Tuguegarao City Government to enter into a Memorandum of Agreement (MOA) for the grant of the said fishing equipment;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement (MOA);

WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Committee on Agriculture found the request to be in order and beneficial to the constituents of Tuguegarao City;

WHEREAS, after the presentation and adoption of the Committee Report and discussion on the matter, the Seventh City Council during their 30th Regular Session deemed it proper and necessary to grant the herein request.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR) for the grant of Ten (10) Fishing Stalls to Ten (10) Constituents of Tuguegarao City.
