**CITY RESOLUTION NO. 103-2017**

**RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE SCHOOLS DIVISION SUPERINTENDENT OF TUGUEGARAO CITY FOR FUNDING BY THE LOCAL SCHOOL BOARD OF THE CLASSROOMS, FURNITURE, FACILITIES AND SALARIES OF THREE TEACHERS OF CARIG NORTE PRIMARY SCHOOL**

**WHEREAS**, upon the request of the Officer-in-Charge Division Superintendent of Tuguegarao City, the City Mayor, Hon. Bienvenido C. De Guzman II, sought authority from this august Body to sign in behalf of the City Government the Memorandum of Agreement with the Schools Division of Tuguegarao City for the funding by the Local School Board of the following items for Carig Norte Primary School:

1. Erection of the two-classroom building;
2. Three (3) teacher's tables and chairs;
3. Other school facilities and equipment incidental thereto; and,
4. Salaries of three (3) teachers until such time the permanent teacher items are granted to the school by the national government

**WHEREAS**, the Committee on Education in its Committee Report No. 040-2017 dated March 6, 2017 favorably recommended the endorsement to the Local School Board for funding of the above-stated items;

**WHEREAS**, as found by the Committee on Education, the necessary funding of the foregoing requested items could be sourced out from the Special Education Fund (SEF) of the Local School Board.

**NOW, THEREFORE**, on joint motion of all Council Members present,



Division Superintendent of the Tuguegarao City for funding by the Local School Board of the classrooms, furniture, facilities and salaries of three teachers of Carig Norte Primary School.
