CITY RESOLUTION NO. 106-2017

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL MAPPING AND RESOURCE INFORMATION AUTHORITY (NAMRIA)

WHEREAS, sometime in 2016, the Tuguegarao City Government requested the National Mapping and Resource Information Authority (NAMRIA) in the issuance of available date and map shapefiles for Tuguegarao City for the purpose of gathering information and maps for database in the formulation of its 2016-2025 Comprehensive Land Use Plan (CLUP) and 2016-2024 City Development Plan (CDP);

WHEREAS, the request for authority to sign the Memorandum of Understanding with National Mapping and Resource Information Authority was endorsed to the Seventh City Council by the City Mayor, Hon. Bienvenido C. De Guzman II;

WHEREAS, the joint Committees to which the matter was referred initially met on March 13, 2017 to discuss the subject referral titled "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Understanding with the National Mapping and Resource Information Authority (NAMRIA) for the free issuance and utilization of the latter's products to be used as reference in the formulation of the City's 2016-2025 Comprehensive Land Use Plan (CLUP) and 2016-2024 City Development Plan";

WHEREAS, NAMRIA through a letter from the Administrator, Dr. Peter M. Tiangco, CESO I, granted the request of the city government for the free issuance and utilization of NAMRIA's products to be used as reference in the formulation of the City's CLUP and CDP;

WHEREAS, the issuance of the data shall be covered by a Memorandum of Understanding (MOU);

WHEREAS, upon review of the subject referral, the Committees find the Memorandum of Understanding (MOU) to be in order, with merit and beneficial to the City Government, hence, the committees favorably recommend for the approval of the Memorandum of Understanding between the National Mapping and Resource Information Authority (NAMRIA) represented by Dr. Peter M. Tiangco



and the Local Government Unit of Tuguegarao represented by the City Mayor, Hon. Bienvenido C. De Guzman II.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Understanding with National Mapping and Resource Information Authority.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Arnel T. Arugay and without any objection, CITY RESOLUTION NO. 106-2017 was APPROVED under suspended rules.
