## **CITY RESOLUTION NO. 123-2017**

A RESOLUTION AMENDING CITY RESOLUTION NO. 072-2017 TITLED
"A RESOLUTION ENDORSING THE APPLICATION FOR REGISTRATION OF NORTHEAST
CONSTRUCTION, MANAGEMENT AND GENERAL MERCHANDISE, INC. OF
INFORMATION TECHNOLOGY ENTERPRISE WITH THE PHILIPPINE ECONOMIC
ZONE AUTHORITY (PEZA)"

WHEREAS, the Northeast Construction, Management and General Merchandise, Inc. is working on the establishment of several Businesses Process Outsource (BPO) Projects in Tuguegarao City;

WHEREAS, one of the requirements needed for the Information Technology Enterprise to be accredited by the Philippine Economic Zone Authority (PEZA) is the Sangguniang Panlungsod Resolution endorsing the application for registration;

WHEREAS, the request for endorsement for application for registration of Information Technology Enterprise and Information Technology Park with the Philippine Economic Zone Authority (PEZA) of Northeast Construction, Management and General Merchandise, Inc. was endorsed to Seventh City Council by the City Mayor, Hon. Jefferson P. Soriano;

WHEREAS, the Committee on Rules, Laws and Ethics has exhaustively studied the request and granted the same since the request is beneficial to the City Government and to the constituents of Tuguegarao City.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to amend City Resolution No. 072-2017 to "A Resolution Endorsing the Application for Registration of Information Technology Park at Bagay, Tuguegarao City with an Area of 53,306 Square Meters and Leonarda, Tuguegarao City with an Area of 61,824 Square Meters with the Philippine Economic Zone Authority (PEZA) of Northeast Construction, Management and General Merchandise, Inc."
