RESOLUTION ADOPTING AND APPROVING COMMITTEE REPORT NO. 053-2017 OF THE COMMITTEE OF THE WHOLE ON THE INVESTIGATION IN AID OF LEGISLATION ON THE DENIAL OF THE TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL (TCPGH) ACCREDITATION OF PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR CALENDER YEAR 2017 DUE TO LAWFUL AND JUSTIFIABLE GROUNDS INVOLVING PHILHEALTH GHOST CLAIMS

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) issued PhilHealth advisory 002-002-03062017 relative to the Non-Renewal of the Philhealth Accreditation of the Tuguegarao City People’s General Hospital for CY 2017 due to the lawful and justifiable grounds involving Philhealth ghost claims;

WHEREAS, Hon. Raymund P. Guzman delivered a Privilege Speech during the 30th Regular Session held on March 06, 2017 relative to the foregoing and the matter was referred to the Committee of the Whole which conducted an investigation last March 17, 22 and 27, 2017 on the said PhilHealth ghost claims;

WHEREAS, after the said series of committee investigations, the Committee of the Whole judiciously came out with Committee Report 053-2017 containing its findings and recommendations;

WHEREAS, during their 34th Regular Session, the Seventh City Council adopted in plenary Committee Report 053-2017 after a cautious deliberation and discussion.

WHEREAS, on the same regular session, the Seventh City Council approved the passage of a resolution adopting and approving Committee Report 053-2017.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to adopt and approve Committee Report No. 053-2017 of the Committee of the Whole on the investigation in aid of legislation on the denial of the Tuguegarao City People’s General Hospital (TCPGH) accreditation of PhilHealth for Calendar Year 2017 due to lawful and justifiable ground involving PhilHealth ghost claims.


