WHEREAS, the Committee on Appropriations reviewed the Annual Budget of Barangay Centro 05 for CY 2017;




On motion of Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 129-2017** was **APPROVED** under suspended rules.
