WHEREAS, in accordance with DILG Memorandum Circular dated February 17, 2011 and DILG Memorandum Circular 2015-128 dated November 2, 2015 providing for the Guidelines for the formulation of Peace and Order and Public Safety Plan, the Tuguegarao City Peace and Order Council Technical Working Group (CPOC-TWG) formulated the POPS Plan for CY 2016-2019;

WHEREAS, the City Development Council has issued CDC Resolution No. 1-2017 endorsing the approval of City Peace and Order and Public Safety (POPS) Plan for CY 2016-2019;

WHEREAS, the City Mayor has endorsed CDC Resolution No. 1-2017 to the Seventh City Council for appropriate action and recommendation;

WHEREAS, after careful deliberation by the Committee on Public Safety and Order and Disaster Preparedness of CDC Resolution No. 1-2017, the Committee found the same to be in order and has favorably recommended for its approval.
