CITY RESOLUTION NO. 150-2017

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO UTILIZE THE CONFIDENTIAL FUND TO IMPLEMENT THE CITY PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN CY 2016-2019

WHEREAS, Section 116 of the Local Government Code provides for the establishment of a Local Peace and Order Council (LPOC) in every province (PPOC), city (CPOC) and municipality (MPOC);

WHEREAS, the Tuguegarao City Peace and Order Council Technical Working Group (CPOC-TWG) formulated the Peace and Order and Public Safety (POPS) Plan for CY 2016-2019 in accordance with DILG Memorandum Circular dated February 17, 2011 and DILG Memorandum Circular 2015-128 dated November 2, 2015 providing for the guidelines for the formulation of Peace and Order and Public Safety Plan;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, has endorsed CDC Resolution No. 01-2017 approving the City Peace and Order and Public Safety (POPS) to the Seventh City Council, the same of which was approved during the 35th Regular Session;

WHEREAS, after a discussion and deliberation on the matter during the committee level meeting and during the 35th Regular Session of the Seventh City Council, both committees concerned and the Council deemed it necessary and proper to authorize the City Mayor to utilize the confidential funds of the City to implement the City Peace and Order and Public Safety (POPS) Plan CY 2016-2019 in the total amount included in the annual budget of the City of Tuguegarao under Appropriation Ordinance No. 04, series of 2016.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to utilize the confidential fund to implement the City Peace and Order and Public Safety (POPS) Plan of CY 2016-2019.


