CITY RESOLUTION NO. 158-2017

ARESOLUTION AMENDING CITY RESOLUTION NO. 094-2017 REPLACING THE PHRASE "TEN (10) UNITS OF FISH STALLS TO TEN (10) CONSTITUENTS OF TUGUEGARAO CITY"

TO "THIRTY-TWO (32) UNITS OF FISH STALLS TO THIRTY-TWO (32)

CONSTITUENTS OF TUGUEGARAO CITY"

WHEREAS, in line with the objectives of the Bureau of Fisheries and Aquatic Resources (BFAR) to increase the fisher folks' production and profitability, it shall grant Fish Stalls to the constituents of Tuguegarao City;

WHEREAS, in order to ensure the successful distribution and preservation of the Fish Stalls to the recipients, there is a need for the Tuguegarao City Government to enter into a Memorandum of Agreement (MOA) for the grant of the said stalls;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement (MOA);

WHEREAS, instead of granting ten (10) units of Fish Stalls to ten (10) constituents, it shall be hirty-two (32) units of Fish Stalls to thirty-two (32) constituents of Tuguegarao City.

WHEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Bundan of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR) for the Bant of thirty-two (32) units of Fish Stalls to thirty-two (32) constituents of Tuguegarao City.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Winnoco R. Abraham and any objection, CITY RESOLUTION NO. 158-2017 was APPROVED under suspended rules.
