CITY RESOLUTION NO. 160-2017

A RESOLUTION GRANTING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AN AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH CAGAYAN STATE UNIVERSITY (CSU) REGARDING THE ON-THE-JOB TRAINING OF STUDENTS IN TUGUEGARAO CITY GOVERNMENT

WHEREAS, the referral which is “Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Cagayan State University (CSU) regarding the On-the-Job Training of students” was referred to the Committee on Rules, Laws and Ethics;

WHEREAS, the Committee initially met on April 20, 2017 to discuss the subject referral and recommended for its approval;

WHEREAS, the Committee on Rules, Laws and Ethics finds the request to be beneficial to the City Government and to the employees and students of Cagayan State University;

WHEREAS, the CSU students who shall undergo the On-the-Job Training at the City of Tuguegarao shall be from the College of Information and Computing Sciences and College of Business, Entrepreneurship and Accountancy (Business Administration, Major in Marketing Management);

WHEREAS, upon review of the Memorandum of Agreement, the Committee recommends for the approval of a Resolution Granting the City Mayor, Hon. Bienvenido C. De Guzman II, an authority to enter into a Memorandum of Agreement with Cagayan State University regarding the On-the-Job Training of students in the Tuguegarao City Government.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant the request for a Sangguniang Panlungsod Resolution Granting the City Mayor, Hon. Bienvenido C.
