CITY RESOLUTION NO. 161-2017

A RESOLUTION GRANTING THE ACTING CITY VICE MAYOR, HON. JUDE T. BAYONA, AN AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH CAGAYAN STATE UNIVERSITY (CSU) REGARDING THE ON-THE-JOB TRAINING OF STUDENTS IN TUGUEGARAO CITY GOVERNMENT

WHEREAS, the referral which is “Memorandum of Agreement between the Cagayan State University, College of Arts and Sciences, represented by its University President, Dr. Urdujah A. Tejada, and the Sangguniang Panlungsod of Tuguegarao, represented by its Acting City Vice Mayor, Hon. Jude T. Bayona, regarding the On-the-Job Training of students” was referred to the Committee on Rules, Laws and Ethics;

WHEREAS, the Committee initially met on April 20, 2017 to discuss the subject referral and recommended for its approval;

WHEREAS, the Committee on Rules, Laws and Ethics finds the request to be beneficial to the City Government and to the employees and students of Cagayan State University;

WHEREAS, the CSU students who shall undergo the On-the-Job Training at the City of Tuguegarao shall be from the College of Arts and Sciences (Bachelor of Arts, Major in Political Science);

WHEREAS, upon review of the Memorandum of Agreement, the Committee recommends for the approval of a Resolution Granting the Acting City Vice Mayor, Hon. Jude T. Bayona, an authority to enter into a Memorandum of Agreement with Cagayan State University regarding the On-the-Job Training of students in the Tuguegarao City Government.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant the request for a Sangguniang Panlungsod Resolution Granting the Acting City Vice Mayor, Hon. Jude T.
