**A RESOLUTION AMENDING CITY RESOLUTION NO. 008-2017 TITLED
 “A RESOLUTION RECOMMENDING THE RECLASSIFICATION/CONVERSION OF
 AGUINALDO EXTENSION, STARTING FROM CORNER VALENZUELA STREET TO
 CAPATAN-LIBAG ROAD, FROM A CITY ROAD TO NATIONAL ROAD” TO
 “A RESOLUTION RECOMMENDING THE RECLASSIFICATION/CONVERSION OF NATIONAL
 ROAD JUNCTION LIBAG-CAPATAN ROAD TO AGUINALDO STREET CORNERS RIZAL
 STREET AND LUNA STREET, FROM A CITY ROAD TO NATIONAL ROAD”**

WHEREAS, under Executive Order No. 124, series of 1987, the Department of Public Works and Highways (DPWH) is mandated to “provide or authorize the conversion of roads”;

WHEREAS, the conversion of National Road Junction Libag-Capatan Road to Aguinaldo Street corners Rizal Street and Luna Street, from City Road to National Road would vest jurisdiction to DPWH-RO2 that includes the funding and maintenance;

WHEREAS, the conversion of any local road requires a resolution from the City Council;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested for a resolution from the Seventh City Council for the herein purpose;

WHEREAS, the Seventh City Council found the same to be in order and beneficial to the constituents of Tuguegarao City.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to recommend the reclassification/conversion of National Road Junction Libag-Capatan Road to Aguinaldo Street corners Rizal Street and Luna Street, from a City Road to National Road.


