**RESOLUTION ADOPTING AND APPROVING THE COMMITTEE OF THE WHOLE  
 (INVESTIGATING BODY) REPORT/DECISION ON  
 ADMINISTRATIVE CASE NO. 01-2016**

**WHEREAS**, on April 24, 2017, a Decision of the majority of the members of the Committee of the Whole (Investigating Body) has been rendered, a copy of which is hereto attached and made an integral part of this Resolution;

**WHEREAS**, the findings, issues and decision in the afore-quoted Administrative Case No. 01-2016 titled **EFREN MABUHAY** and **MARVIN LLANTO versus BARANGAY CAPTAIN RESTITUTO BUQUEL, KAGAWAD EMMA JOSE** and **BARANGAY TREASURER MEDINA REMUDARO** are in accordance and pursuant to law and jurisprudence, the dispositive portion of which is hereunder reproduced as follows;

“Wherefore, it is the recommendation of the Committee of the Whole (Investigating Body) that the penalty of Suspension from office for Six (6) months be imposed upon Respondents Punong Barangay Restituto Buquel and Kagawad Emma Jose. We also recommend the filing of appropriate criminal/civil action with the proper courts. Let this Decision be implemented by the Hon. Mayor Bienvenido C. De Guzman II and to submit a Compliance Report within five (5) days from receipt. A copy of this decision is furnished to the Punong Barangay/Council for their appropriate action in so far as Barangay Treasurer Medina Remudaro is concerned and to submit a report within thirty (30) days from receipt hereof.”
