A RESOLUTION AMENDING CITY RESOLUTION NO. 182-2016 TITLED “RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE AUTHORITY TO SIGN THE INTERNSHIP AGREEMENT AND MEMORANDUM OF UNDERSTANDING FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RO2”

WHEREAS, pursuant to Government Internship Program (GIP) of the Department of Labor and Employment (DOLE), the department through Regional Office 02 wanted to enter into an understanding with the Tuguegarao City Government for the purpose of achieving the program’s goals, that is, to provide opportunities and engage young workers to serve the general public in government agencies/entities at the national and local levels;

WHEREAS, the purpose of the Memorandum of Understanding is to implement the DOLE-GIP in cooperation and partnership with the City Government and other government agencies and instrumentations to promote the youth’s exposure to public service;

WHEREAS, the DOLE through the Regional Office 02 shall implement the Government Internship Program (GIP) and undertake to provide and assign the intern-beneficiaries to the City Government of Tuguegarao to perform tasks and duties under the said Memorandum of Understanding and Internship Agreement;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Seventh City Council the Internship Agreement and Memorandum of Understanding for perusal and for an authority to enter into the said Memorandum of Understanding and Internship Agreement;

WHEREAS, after an extensive discussion during the committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics found the terms and conditions in the Internship Agreement and Memorandum of Understanding to be in order and with merit.


