**CITY RESOLUTION NO. 171-2017**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE PREPAID CARD AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES**

**WHEREAS**, the request for authority to sign the Prepaid Card Agreement with the Development Bank of the Philippines (DBP) was endorsed to the Seventh City Council by the City Mayor, Hon. Bienvenido C. De Guzman II;

**WHEREAS**, the Committee initially met on April 28, 2017 with the resource persons who discussed the subject referral titled "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Prepaid Card Agreement with the Development Bank of the Philippines";

**WHEREAS**, as one of the City Government's Depository Banks, the Development Bank of the Philippines (DBP) is offering its various payment products and services to the Tuguegarao City Government;

**WHEREAS**, one of the requirements for the availment is the Prepaid Card Agreement between the Tuguegarao City Government and the Development Bank of the Philippines (DBP);

**WHEREAS**, the Committee on Rules, Laws and Ethics found the request to be in order, with merit and beneficial to the City Government and to the constituents of Tuguegarao City;

**WHEREAS**, upon review of the said request, the Committee favorably recommends for the approval of the Prepaid Card Agreement and the passage of a Resolution Granting Authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government with the Development Bank of the Philippines (DBP);




