**WHEREAS**, the request for authority to sign the Terms of Reference with the Local Government Academy (LGA) and Department of the Interior and Local Government (DILG) for the implementation of Sustainable Development Goals Family-Based Actions for Children and their Environs in the Slums (SDG-FACES) Projects in Cities was endorsed to the Seventh City Council by the City Mayor, Hon. **WHEREAS**, the Committees found the Terms of Reference to be in order, with merit and beneficial to the City Government and to the constituents of Tuguegarao City;




On motion of Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 172-2017** was **APPROVED** under suspended rules.
