CITY RESOLUTION NO. 173-2017

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT ACADEMY (LGA) AND DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF SUSTAINABLE DEVELOPMENT GOALS FAMILY-BASED ACTIONS FOR CHILDREN AND THEIR ENVIRONS IN THE SLUMS (SDG-FACES) PROJECTS IN CITIES

WHEREAS, the request for authority to sign the Memorandum of Agreement with the Local Government Academy (LGA) and the Department of the Interior and Local Government (DILG) was endorsed to the Seventh City Council by the City Mayor, Hon. Bienvenido C. De Guzman II;

WHEREAS, the Committees initially met on April 28, 2017 with resource persons who discussed the subject referral titled "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, on the Terms of Reference of the Sustainable Development Goals Family-Based Actions for Children and their Environs in the Slums (SDG-FACES) Projects in Cities and requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Local Government Academy (LGA) and Department of the Interior and Local Government (DILG) for the implementation of SDG-FACES Project in Cities";

WHEREAS, the Sustainable Development Goals (SDG) is a universal call to action adopted by 193 Members of the United Nations including the Philippines;

WHEREAS, the Local Government Academy (LGA) of the Department of the Interior and Local Government is implementing the project which is an offer to localize SDG;

WHEREAS, a project fund in the amount of P50,000.00 will be downloaded to the coffers of the City by the LGA through the DILG Regional Office No. 02;

WHEREAS, the Committees carefully deliberated and perused the Memorandum of Agreement of the SDG-FACES Projects for Cities;

WHEREAS, the Committees found the project and Memorandum of Agreement to be in order, with merit and beneficial to the City Government and to the constituents of Tuguegarao City;


WHEREAS, upon review of the said request, the Committees favorably recommend for the approval of the Memorandum of Agreement and the passage of a Resolution Granting Authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Local Government Academy (LGA) and Department of the Interior and Local Government (DILG) for the implementation of the SDG-FACES in Tuguegarao City.


