## **CITY RESOLUTION NO. 185-2017**

# RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO ENTER FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE VISTAGREEN CORPORATION (VC)

WHEREAS, the request for an authority to sign the Memorandum of Agreement with the Vistagreen Corporation (VC) was endorsed to the Seventh City Council by the City Mayor, Hon. Bienvenido C. De Guzman II;

WHEREAS, the Committee initially met on March 16, 2017 with resource persons who discussed the subject referral titled "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Vistagreen Corporation (VC) for the installation, operation and maintenance of the small, modular, renewable energy of Municipal Solid Waste (MSW) Processing Project, for consideration";

WHEREAS, the representative of Vistagreen Corporation (VC) gave a brief presentation about the Company's Profile and offered Waste Processing Services to the City Government through the installation, procurement, operation and maintenance of the proposed Waste Processing Plant (WPP);

WHEREAS, the Committee again met on April 28, 2017 to finally deliberate on the Memorandum of Agreement with the presence of resource persons;

WHEREAS, the project is pursuant to Republic Act No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000";

WHEREAS, the technological services offered will address the issue on Ecological Solid Waste Management and eliminate the need for additional dumpsite/landfill or Solid Waste Disposal of the City Government of Tuguegarao;



WHEREAS, the Vistagreen Corportation (VC) will invest Waste Processing Plant at No Cost to the Local Government Unit of Tuguegarao City under the terms and conditions of the Memorandum of Agreement for the period of twenty (20) years;

WHEREAS, the Tuguegarao City Government shall provide only a site to house the two (2) units of Waste Processing Plant and deliver its existing and daily segregated Solid Waste Materials for the Processing of Vistagreen Corporation who shall process the same and shall own it;

WHEREAS, upon review of the said request, the Committee favorably recommends for the approval of the Memorandum of Agreement and the passage of a Resolution Granting Authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Vistagreen Corporation (VC);

WHEREAS, the venue of any legal actions arising out of the Memorandum of Agreement shall be Tuguegarao City, not Quezon City;

WHEREAS, the comments, observations and questions of Hon. Maila Rosario T. Que are appended to this resolution.

NOW, THEREFORE, RESOLVED, as it is hereby RESOLVED, to approve the request for the passage of a Resolution Granting Authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to enter for and on behalf of the Tuguegarao City Government with the Vistagreen Corporation, subject to the usual accounting and auditing rules and regulations.

On motion of Hon. Raymund P. Guzman, with seven (7) Members voting in favor (Hon. Raymund P. Guzman, Hon. Arnel T. Arugay, Hon. Grace B. Arago, Hon. Imogen Claire M. Callangan, Hon. Kendrick S. Calubaquib, Hon. Jose Pedro G. Velasco and Hon. Winnoco R. Abraham), one (1) against (Hon. Maila Rosario T. Que) and one (1) abstention (Hon. Mary Marjorie P. Martin-Chan), CITY RESOLUTION NO. 185-2017 was APPROVED under suspended rules.
