**RESOLUTION ADOPTING AND APPROVING THE COMMITTEE OF THE WHOLE

WHEREAS, on May 11, 2017, a Decision of the majority of the members of the Committee of the Whole (Investigating Body) has been rendered, a copy of which is hereto attached and made an integral part of this Resolution;

WHEREAS, the Findings, Issues and Decision in the afore mentioned Administrative Case No. 04-2015 titled "Jhony Pingad versus Hon. Hilario Larry S. Ting" is in accordance and pursuant to law and jurisprudence, the dispositive portion of which is hereunder reproduced as follows:

"Wherefore, it is the recommendation of the Committee of the Whole (Investigating Body) that the penalty of suspension from office for six (6) months without pay as Punong Barangay, Centro 07, Tuguegarao City and consequently as the ABC-President of Tuguegarao City Chapter, ABC Federation President of Cagayan Chapter and Ex-Officio Member of the Provincial Board, Province of Cagayan be imposed upon Respondent Hilario Larry S. Ting. Let this Decision be implemented by the City Mayor, Hon. Bienvenido C. De Guzman II, and to submit a compliance report within five (5) days from receipt. Let copies of this decision be furnished to the Office of the ABC-Tuguegarao Chapter, ABC-Cagayan Chapter, Hon. Melvin Vargas, Jr., Vice Governor, Provincial Capitol, Hon. Manuel N. Mamba, Governor, Provincial Capitol, City LGOO and Provincial LGOO, for their information and guidance."


