RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) AMONG THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) REGION 02, THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO AND MR. SERVANDO GUMABAY FOR THE INTEGRATED FARMING (MODIFIED RICE-FISH FARMING) TECHNOLOGY DEMONSTRATION CUM LIVELIHOOD PROJECT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR THE SAID MOA FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT

WHEREAS, one of the essential objectives of the Bureau of Fisheries and Aquatic Resources (BFAR) is to increase fish farmers' production and profitability;

WHEREAS, there is a need to develop and manage available fishery resources to provide fisherfolk with livelihood and source of income;

WHEREAS, one of the projects of BFAR to scale up fish productivity in the region is by providing fish farmers tilapia fingerlings, enough knowledge on the operation and management of fishpond and technical assistance;

WHEREAS, it is the strategy of the BFAR that expenses in the implementation of the project will be shared with LGU and beneficiaries to ensure its success;

WHEREAS, the LGU and the fishpond operators at field levels are strong partners of the BFAR in implementing projects that will showcase the potentials of aquaculture farming;

WHEREAS, the joint Committee on Agriculture and Food and Committee on Rules, Laws and Ethics met on May 30, 2017 to deliberate on the subject referral titled "*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman ii, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement with the Bureau of Fisheries and Aquatic Resources, Region 02, Mr. Servando Gumabay and Mr. Orlando Macanang for the implementation of the Integrated*

WHEREAS, the joint committees found the terms and condition on the Memorandum of Agreement to be in order and beneficial to the constituents of Tuguegarao City.




