WHEREAS, these criminal acts must be abated the soonest possible time to bring back the peace and tranquility of the City.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to condemn the recent unsolved killings in Tuguegarao City.

RESOLVED FURTHER, to furnish a copy of this resolution to the Philippine National Police, for information and proper action.


On motion of Hon. Winnoco R. Abraham and without any objection, **CITY RESOLUTION NO. 204-2017** was **APPROVED**.
