### A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH UNIVERSITY OF SAINT LOUIS TUGUEGARAO (USL) REGARDING THE ON-THE-JOB TRAINING OF STUDENTS

WHEREAS, University of Saint Louis Tuguegarao (USLT) requested for the On-the-Job Training of students at the Tuguegarao City Government;

WHEREAS, the USLT students who shall undergo the On-the-Job Training at the Tuguegarao City Government are enrolled in the degree Bachelor of Arts, Major in Legal Management;

WHEREAS, upon review of the Memorandum of Agreement during its 43<sup>rd</sup> Regular Session, the Seventh City Council recommends for the approval of a Resolution Granting Authority to the City Mayor, Hon. Bienvenido C.
