CITY RESOLUTION NO. 206-2017

RESOLUTION APPROVING THE DEED OF DONATION AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE DEED OF DONATION OF ONE (1) HIGH LADDERIZED FIRE TRUCK AND TWO (2) MINI PUMPER FIRE TRUCKS TO THE TUGUEGARAO CITY FIRE STATION

WHEREAS, the Tuguegarao City Fire Station is the partner of the Tuguegarao City Government in ensuring the public safety of the constituents of the City;

WHEREAS, in order for the Tuguegarao City Fire Station to realize its mandate of safeguarding the lives and properties of the people in the City, there is an urgent need to upgrade their facilities and equipment to quickly respond in case of fire incidents;

WHEREAS, as a way of a strong support to the said mandate, the Tuguegarao City Government donates one (1) high ladderized fire truck and two (2) mini pumper fire trucks to the Tuguegarao City Fire Station;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council for the approval of the Deed of Donation and to grant him an authority to sign for and on behalf of the Tuguegarao City Government the Deed of Donation for the said two (2) equipment;

WHEREAS, the Seventh City Council during its 43rd Regular Session deemed it proper, necessary and beneficial to approve the Deed of Donation and grant the said authority to the City Mayor.

NOW, THEREFORE, RESOLVED, as it is hereby RESOLVED, to approve the Deed of Donation between the Tuguegarao City Government and Tuguegarao City Fire Station for the donation of one (1) High Ladderized Fire Truck and two (2) Mini Pumper Fire Trucks.

RESOLVED FURTHER, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign the said Deed of Donation for and on behalf of the Tuguegarao City Government.
