**RESOLUTION ADOPTING AND APPROVING CDC RESOLUTION NO. 02-2017 TITLED  
 “RESOLUTION FAVORABLY ENDORSING THE APPROVAL OF THE REPROGRAMMING OF  
 THE PROGRAM OF WORK FOR THE ACQUISITION OF ONE (1) UNIT BRAND NEW  
 BUS TO TWO (2) UNITS BRAND NEW MINI BUSES”**

**WHEREAS**, the City Development Council (CDC) Executive Committee has approved CDC Resolution No. 02-2017 titled “Resolution Favorably Endorsing the Approval of the Reprogramming of the Program of Work for the Acquisition of One (1) Unit Brand New Bus to Two (2) Units Brand New Mini Buses”;

**WHEREAS**, the amount of Eight Million Pesos (Php8,000,000.00) allocated for the project was sourced from the Capital Outlay for CY 2016 amounting to Two Million Pesos (Php2,000,000.00) and from the Supplemental Budget No. 02 CY 2016 amounting to Six Million Pesos (Php6,000,000.00) certified free from any obligation and available for appropriation by the City Treasurer and City Accountant;

**WHEREAS**, the proposed reprogramming was a result of the Revised Motor Vehicle Classification and Specifications Guide of the Revised Guidelines on the Acquisition and Use of Government Motor Vehicles as stated in Department of Budget and Management (DBM) Circular No. 2016-5 dated August 22, 2016;

**WHEREAS**, the Tuguegarao City Government urgently needs the two (2) units brand new buses for its basic services;

**WHEREAS**, the City Mayor, Hon. Bienvenido C. De Guzman II, forwarded to the Seventh City Council CDC Resolution No. 02-2017 for appropriate action;

**WHEREAS**, the Seventh City Council during its 43<sup>rd</sup> Regular Session deemed it proper and necessary to adopt and approve CDC Resolution No. 02-2017.




