CITY RESOLUTION NO. 208-2017

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RO2 AND OTHER PARTICIPATING AGENCIES FOR THE IMPLEMENTATION OF THE DOLE RO2 PROGRAMS AND PROJECTS

WHEREAS, in line with the vision of the Department of Labor and Employment (DOLE) to make every Filipino worker attain full, decent and productive employment, DOLE RO2 is mandated to provide gainful employment opportunities, develop human resources, protect workers and promote their welfare to maintain industrial peace;

WHEREAS, to realize its vision, the Department of Labor and Employment (DOLE) enters into a Memorandum of Agreement with the National Labor Relations Commission (NLRC) RO2, the Philippine Overseas Employment Administration (POEA), the Overseas Workers and Welfare Administration (OWWA) RO2, Social Security System (SSS), Philippine Health Insurance Corporation (PhilHealth), Home Development Mutual Fund (Pag-Ibig), Regional Tripartite Wage and Productivity Board (RTWPB) and the Local Government Unit (LGU) of Tuguegarao City;

WHEREAS, the said partnership among DOLE and the different participating agencies shall ensure that programs and projects geared towards the attainment of social legislation for the labor sector will be implemented;

WHEREAS, Tuguegarao City, being the regional center for trade and business, is the partner of DOLE in the implementation of its various plans, programs and activities for the benefit of the labor force;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA);

WHEREAS, the Seventh City Council during its 43rd Regular Session deemed it proper and necessary to grant the said request.


NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Labor and Employment (DOLE) RO2 and other participating agencies for the implementation of the DOLE RO2 programs and projects.

RESOLVED FURTHER, to furnish copies of this Resolution to the Department of Labor and Employment (DOLE) RO2 and to the other participating agencies, for their information and proper action.


