CITY RESOLUTION NO. 209-2017

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RO2 ON THE IMPLEMENTATION OF PAVVURULUN LIVELIHOOD BAKERY LOCATED AT CAPATAN, TUGUEGARAO CITY

WHEREAS, in line with the vision of the Department of Labor and Employment (DOLE) to make every Filipino worker attain full, decent and productive employment, DOLE RO2 is mandated to provide gainful employment opportunities, develop human resources, protect workers and promote their welfare to maintain industrial peace;

WHEREAS, DOLE RO 2 has been given the responsibility to implement the DOLE Livelihood (Kabuhayan) Program to enable the unemployed poor, seasonal and low-wage workers to start individual livelihood or collective enterprise undertakings with the goal of moving them out to poverty and making them productive;

WHEREAS, Tuguegarao City Government is an accredited and experienced partner of DOLE in the implementation of the said project to achieve the desired social outcomes;

WHEREAS, the Livelihood Project shall be for twenty-five (25) beneficiaries;

WHEREAS, the City Mayor, Hon. Bienvenido C. De Guzman II, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement for the project;

WHEREAS, the Seventh City Council during its 43rd Regular Session deemed it proper, necessary and beneficial to grant the said request.


