CITY RESOLUTION NO. 210-2017

RESOLUTION ENCOURAGING ALL MEMBERS OF TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (TODA) IN THE CITY OF TUGUEGARAO TO REGISTER AS MEMBERS OF THE PAG-IBIG FUND PURSUANT TO THE PROVISIONS OF REPUBLIC ACT NO. 9679, OTHERWISE KNOWN AS "HOME DEVELOPMENT MUTUAL FUND LAW OF 2009"

WHEREAS, Republic Act No. 9679, otherwise known as the "Home Development Mutual Fund Law of 2009", is the law that aims to strengthen the ability of PAG-IBIG to achieve the objectives of improving the quality of life of Filipinos through the provision of adequate housing, by providing a national system of savings and by mobilizing funds for housing programs;

WHEREAS, the above mentioned law requires for universal coverage of its membership and it includes those informal groups and even those earning one thousand pesos/month (P1,000.00) to become PAG-IBIG Fund members;

WHEREAS, by virtue of the universal coverage concept of Republic Act No. 9679, otherwise known as the "Home Development Mutual Fund Law of 2009", and in the spirit of social justice and national development, the government intensified its campaign to equally encourage tricycle operators and drivers to become PAG-IBIG Fund members since the law itself allows that membership may also be extended to other working groups, with or without employer contributions;

WHEREAS, the transportation sector in Tuguegarao City particularly the Tricycle Operators and Drivers Association (TODA) is one among other working groups identified to be eligible for PAG-IBIG Fund membership in order to avail the benefits of provident savings and home financing.

NOW, THEREFORE, RESOLVED, as it is hereby RESOLVED, to require all members of the Tricycle Operators and Drivers Association (TODA) in the City of Tuguegarao to register as members of
