### **CITY RESOLUTION NO. 211-2017**

A RESOLUTION GRANTING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE CAGAYAN STATE UNIVERSITY FOR THE PLANTING OF BAMBOO SEEDLINGS ALONG SELECTED BARANGAYS OF TUGUEGARAO CITY

WHEREAS, the referral which is "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Cagayan State University for the planting of bamboo seedlings along selected barangays of Tuguegarao City" was endorsed to the Seventh City Council;

WHEREAS, the Committees to which the matter was referred to, met on June 14, 2017 to discuss the subject referral;

WHEREAS, as an advocacy, Cagayan State University has been conducting extensive and community development services through its technical assistance in the implementation of the planting of bamboo seedlings;

WHEREAS, there is a need to maintain and protect bamboo tree plantation along the riverbeds of selected barangays of Tuguegarao City;

WHEREAS, the project will be in collaboration with the barangay folks and barangay officials of the selected barangays who are recipients of the activity;

WHEREAS, upon review of the Memorandum of Agreement, the Committee on Rules, Laws and Ethics and the Committee on Climate Change, Environmental Protection and Ecology recommend for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the City Mayor, Hon. Bienvenido C. De Guzman II, the authority to sign for and on behalf of the Tuguegarao City with the Cagayan State University.

NOW, THEREFORE, RESOLVED, as it is hereby RESOLVED, to approve the Memorandum of Agreement between the Tuguegarao City Government and the Cagayan State University for the planting of bamboo seedlings along selected barangays of Tuguegarao City.

RESOLVED FURTHER, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement.

**RESOLVED FINALLY**, to prioritize the most affected/vulnerable barangays in the City in terms of the effects of soil erosion.

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Grace B. Arago and without any objection, CITY RESOLUTION NO. 211-2017 was APPROVED under suspended rules.
