WHEREAS, the approved Executive-Legislative Agenda (ELA) for CY 2016-2019 included the repair of the drainage system and the lighting system of the Don Domingo Public Market and the relocation and landbanking for the Tuguegarao City People’s General Hospital;

WHEREAS, Typhoon Lawin exacerbated the poor conditions of the Don Domingo Public Market and heightened the need to construct a bigger facility for the Tuguegarao City People’s General Hospital in a new location;

WHEREAS, the City Development Council (CDC) has approved CDC Resolution No. 4-2017 titled “*Resolution Approving the Construction of the Don Domingo Public Market and the Tuguegarao City People’s General Hospital*”;

WHEREAS, the Seventh City Council during its Special Session held on June 22, 2017, deemed it proper and necessary to approve CDC Resolution No. 4-2017.


