WHEREAS, pursuant to the provision of Section 21 (d) of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to conduct a “Presyo Agawid”/ Baratilyo;

WHEREAS, a tradition and part of the celebration of the 293rd Patronal Feast of Tuguegarao is the “Presyo Agawid”/ Baratilyo which is usually held at the portions of some streets of Tuguegarao City;

WHEREAS, a comprehensive and integrated plan on transfer and relocation, traffic management, safety and security, and health and sanitation including the site plan and layout for the conduct of the “Presyo Agawid”/ Baratilyo 2017 was submitted to the Seventh City Council;


