CITY RESOLUTION NO. 223-2017

A RESOLUTION AUTHORIZING THE MONETIZATION OF LEAVE CREDITS OF TUGUEGARAO CITY GOVERNMENT OFFICIALS AND EMPLOYEES

WHEREAS, Section 458 (1) (viii) of R.A. 7160 or the Local Government Code of 1991 provides that the Sanggunian has the power to determine other emoluments and benefits of city officials and employees paid solely or mainly from local funds;

WHEREAS, CSC-DBM Joint Circular No. 2, s. 2003 provides that "*monetization of leave credits is authorized by law, is generally chargeable against savings of the LGU, but may also be included by direct appropriation in the annual/supplemental budget,*" provided that the Personal Services (PS) Limitations as stipulated under Section 325 (a) of R.A. 7160 is not exceeded;

WHEREAS, a written request for the monetization of leave credits was submitted by city employees;

WHEREAS, the request for monetization of leave credits is worth considering due to high cost of living, educational expenses and other financial obligations.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the monetization of leave credits of Tuguegarao City Government officials and employees, equivalent to ten (10) days leave credit, provided that the Personal Services Limitations is not exceeded and the monetization shall not be mandatory.

RESOLVED FURTHER, that funding for said purpose shall be allocated and appropriated in the Second Supplemental Budget for FY 2017 of Tuguegarao City.

RESOLVED FINALLY, to forward this Resolution to the City Mayor, Hon. Bienvenido C. De Guzman II, for information and appropriate action.


