CITY RESOLUTION NO. 227-2017

A RESOLUTION GRANTING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) RO2 FOR THE IMPLEMENTATION OF THE DOLE LIVELIHOOD (KABUHAYAN) PROGRAM - LIVELIHOOD ENHANCEMENT THROUGH THE STARTER KIT PROGRAM FOR FIFTEEN (15) PERSONS WITH DISABILITIES (PWDs)

WHEREAS, the referral which is “*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Labor and Employment (DOLE) RO2 for the implementation of the DOLE Livelihood (Kabuhayan) Program – Livelihood Enhancement through the STARTER Kit Program for fifteen (15) persons with disabilities (PWDs)*” was endorsed to the Seventh City Council;

WHEREAS, the Committees to which the matter was referred to met on July 04, 2017 and July 06, 2017 to discuss the subject referral;

WHEREAS, the Department of Labor and Employment (DOLE) in its mandate endeavors to contribute to reducing poverty by providing access to livelihood undertakings through the implementation of the DOLE Livelihood (Kabuhayan) Program;

WHEREAS, Tuguegarao City has been accredited by DOLE to be capable and experienced in implementing the proposed project for fifteen (15) beneficiaries particularly Persons with Disabilities (PWDs) from various barangays of Tuguegarao City;

WHEREAS, the fund assistance amounting to One Hundred Sixty Five Thousand Pesos (P165,000.00) shall be used exclusively for the implementation of the project. The fifteen (15) beneficiaries will receive Ten Thousand Pesos (P10,000.00) each in the form of equipment, tools and materials as starter kits;

WHEREAS, upon review of the Memorandum of Agreement, the Joint Committee on Rules, Laws and Ethics and Committee on Cooperatives and Livelihood recommend for the approval of the

Memorandum of Agreement and a Resolution Granting the City Mayor, Hon. Bienvenido C. De Guzman II, an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Labor and Employment (DOLE).


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Department of Labor and Employment (DOLE) RO2 for the implementation of the DOLE Livelihood (Kabuhayan) Program – Livelihood Enhancement through the STARTER Kit Program for fifteen (15) Persons with Disabilities (PWDs).

RESOLVED FURTHER, to grant authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.


On motion of Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 227-2017** was **APPROVED** under suspended rules.
