**CITY RESOLUTION NO. 229-2017**

**A RESOLUTION GRANTING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL LOCAL GOVERNMENT UNIT, CAGAYAN VALLEY MEDICAL CENTER (CVMC), DEPARTMENT OF HEALTH (DOH), DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), CAGAYAN PROVINCIAL HEALTH OFFICE (CPOH), CITY HEALTH OFFICE (CHO), CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO) AND NON-GOVERNMENTAL ORGANIZATIONS (NGOs) TO PROVIDE WHEELCHAIRS AND OTHER MOBILITY AIDS (“DEVICES”) AND RELATED SERVICES TO IMPROVE THE MOBILITY OF INDIVIDUALS WITH PHYSICAL DISABILITIES**

**WHEREAS**, the referral which is “*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Local Government Unit, Cagayan Valley Medical Center (CVMC), Department of Health (DOH), Department of Social Welfare and Development (DSWD), Cagayan Provincial Health Office (CPOH), City Health Office (CHO), City Social Welfare and Development Office (CSWDO) and Non-Governmental Organizations (NGOs) to provide wheelchairs and other mobility aids (“DEVICES”) and related services to improve the mobility of individuals with physical disabilities*” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee to which the matter was referred to met on July 04, 2017 and July 06, 2017 to discuss the subject referral;

**WHEREAS**, the different line agencies and stakeholders, namely: Provincial Local Government Unit, Cagayan Valley Medical Center (CVMC), Department of Health (DOH), Department of Social Welfare and Development (DSWD), Cagayan Provincial Health Office (CPOH), City Health Office (CHO), City Social Welfare and Development Office (CSWDO) and Non-Governmental Organizations (NGOs) agreed to cooperate in a humanitarian project to provide wheelchairs and other mobility aids “DEVICES” and related services to improve the mobility of individuals with disabilities;

**WHEREAS**, the agreement by the mentioned parties is a result of the agreement entered into by the Latter-Day Saints Charities-Phils., Inc. ("LDS-C"), a non-profit organization that conducts charitable and humanitarian activities;

**WHEREAS**, the Cagayan Valley Medical Center (CVMC) under the Department of Health (DOH) was tasked to distribute the devices to the qualified indigent beneficiaries with disabilities;

**WHEREAS**, it will be a continuous project and permanent endeavor of CVMC in consultation with the different line agencies and stakeholders;

**WHEREAS**, upon review of the Memorandum of Agreement, the Committee on Rules, Laws and Ethics recommends for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the City Mayor, Hon. Bienvenido C. De Guzman II, an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Provincial Local Government Unit, Cagayan Valley Medical Center (CVMC), Department of Health (DOH), Department of Social Welfare and Development (DSWD), Cagayan Provincial Health Office (CPOH), City Health Office (CHO), City Social Welfare and Development Office (CSWDO) and Non-Governmental Organizations (NGOs).




