CITY RESOLUTION NO. 230-2017

A RESOLUTION GRANTING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH CAGAYAN STATE UNIVERSITY FOR THE IMPLEMENTATION OF THE PROJECT TITLED “THE INSTALLATION OF HYBRID SOLAR POWER SYSTEM WITH INTEGRATED WATER HARVESTING FACILITY AT THE PEOPLE’S GYMNASIUM”

WHEREAS, the referral which is “*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with Cagayan State University (CSU) regarding the installation of Hybrid Solar Power System with Integrated Water Harvesting Facility at the People’s Gymnasium*” was endorsed to the Seventh City Council;

WHEREAS, the Committees to which the matter was referred to met on July 04, 2017 and July 06, 2017 to discuss the subject referral;

WHEREAS, the Cagayan State University (CSU) in partnership with Asian Cities Climate Change Resilience Network (ACCCRN) Engagement Building Small Grants Fund, Local Governments for Sustainability – Southeast Asia Secretariat (ICLEI-SEAS) is implementing the project titled “*Installation of Hybrid Solar Power System*” with Integrated Water Harvesting Facility at the People’s Gymnasium;

WHEREAS, Tuguegarao City is identified as one of the beneficiaries of the project;

WHEREAS, the Local Government Unit of Tuguegarao City in collaboration with the Cagayan State University shall implement the project for a period of one (1) year. The turnover of the project was conducted on June 19, 2017 at the People’s Gymnasium, it is expected to end in June 2018;

WHEREAS, the Water Harvesting Facility can be used by the Bureau of Fire Protection (BFP) in combatting fire occurrences and the water facility will also address the needs of evacuees to be stationed at the People’s Gymnasium during calamities;

WHEREAS, upon review of the Memorandum of Agreement, the Joint Committee on Rules, Laws and Ethics and Committee on Infrastructure and Public Utilities recommend for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the City Mayor, Hon. Bienvenido C. De Guzman II, an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Cagayan State University.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Cagayan State University regarding the installation of Hybrid Solar Power System with Integrated Water Harvesting Facility at the People's Gymnasium.

RESOLVED FURTHER, to grant authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.


