**WHEREAS, CPL RONALD BRUNO SUPNAD, JR.** was pinned down during one of the clearing operations of the Armed Forces of the Philippines in Marawi City;

**WHEREAS,** records show that **CPL RONALD BRUNO SUPNAD, JR.** has finished his elementary education in Tuguegarao North Central School in 2000 and his secondary education in Cagayan National High School in 2004;

**WHEREAS, CPL RONALD BRUNO SUPNAD, JR.** has attended military schooling in the Basic School, MCTC, MBRB, Fort Bonifacio, Taguig City, from March 31, 2011 to October 14, 2011;

**WHEREAS, CPL RONALD BRUNO SUPNAD, JR.** is a recipient of numerous awards and medals such as Military Civic Action Medal under GO #90 3MBDE DTD dated 13 September 2012, for

having rendered meritorious and outstanding services in the field of civic action and direct support to civil military operation in the remote places within Indanan, Sulu from January 12 to June 30, 2012;

**WHEREAS**, the death of **CPL RONALD BRUNO SUPNAD, JR.** is a great loss to the nation's quest for peace and stability in Mindanao and in solving the conflict in Marawi City;

**WHEREAS**, the people of Tuguegarao and the entire nation are in solidarity with the grieving of the family, relatives and friends of **CPL RONALD BRUNO SUPNAD, JR.**

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, that a Resolution of Posthumous Commendation be given to **CPL RONALD BRUNO SUPNAD, JR.**, for his heroism, valor and gallantry in pursuit of the country's quest for peace and solidarity, and to express heartfelt condolences to his family.
