CITY RESOLUTION NO. 236-2017

A RESOLUTION APPROVING THE ACCREDITATION OF PEACE, ACTION AND RESCUE WITH DEDICATION TO SERVE THE SOCIETY (PARDSS) AS A CIVIL SOCIETY ORGANIZATION BASED IN TUGUEGARAO CITY PURSUANT TO DILG MC NO. 2016-97

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2016-97 "Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies" dated July 19, 2016;

WHEREAS, the said Memorandum of Agreement reiterates the provisions of the Local Government Code relative to the accreditation of civil society organizations and in the selection of representatives to the local special bodies to strengthen their participation in local governance and development processes;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City recognizes the vital role of Civil Society Organizations (CSOs) which include non-stock and non-profit associations, non-governmental organizations, people's organizations, civil organizations, cooperatives, social movements and professional and business groups in nation building and their collective efforts towards progress;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City through the Committee on Rules, Laws and Ethics has reviewed and approved the application for accreditation of the Peace, Action and Rescue with Dedication to Serve the Society (PARDSS) having complied with the documentary requirements;

WHEREAS, the accreditation shall be valid for three (3) years commencing upon approval of this resolution up to June 2019;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City reserves the right to revoke and/or cancel the accreditation in the event that they fail to comply with their undertakings or for any violation of existing laws, rules and regulations.
