## CITY RESOLUTION NO. 237-2017

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C, DE GUZMAN II, TO LOOK FOR AVAILABLE AREA/SITE SUITABLE FOR THE LOCATION OF A FIRE STATION PREFERABLY AT THE BUSINESS/COMMERCIAL DISTRICT AND URBAN CENTER AND TO NEGOTIATE FOR THE PURCHASE/ACQUISITION AND/OR EXPROPRIATION PROCEEDINGS FOR A LOT NOT LESS THAN FIVE HUNDRED (500) SQUARE METERS

WHEREAS, the referral which is "Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to enter for and on behalf of the Tuguegarao City Government the Deed of Usufruct with the Bureau of Fire Protection (BFP) – Tuguegarao City Fire Station for the construction of a typical City Fire Station" was endorsed to the Seventh City Council;

WHEREAS, the Committee to which the matter was referred met on July 6, 2017 to discuss the subject referral;

WHEREAS, one of the priorities of the Bureau of Fire Protection – National Headquarters is the submission of priority programs for the construction of a typical City Fire Station;

WHEREAS, Tuguegarao City is one among the biggest population and progressive cities in Region 02 and there is a need to construct a typical City Fire Station for easy and quick response to any emergencies and for the effective and efficient delivery of services by the fire station to the needs of the people of Tuguegarao City;

WHEREAS, the construction of the building will solve the housing of the growing number of personnel, clients, fire trucks and other firefighting equipment/facilities of the Tuguegarao City Fire Station;

WHEREAS, the Assistant City General Services Officer, Mr. Jude W. Santos, informed the committee of the availability of a 3,315 square meter parcel of land owned by the City Government located within the City Hall Complex at the Regional Government Center, Carig Sur, Tuguegarao City;

WHEREAS, the Committee noted the amendment of the office address and name of the representative of the Bureau of Fire Protection from Fire/Chief Inspector Michael C. Castillo, City Fire Marshal, to Sr/Supt. Joselito Cortez, Regional Director, with principal office address at BFP RO2, Pattaraddayan Regional Government Center, Carig Sur, Tuguegarao City;

WHEREAS, the Committee further discussed that the ideal and suitable priority location of the area/site of the fire station should be at the business district, commercial as well as urban center for quick response, hence, the necessity to negotiate for the purpose of a lot or expropriation proceedings;

WHEREAS, upon review of the said request, the Committee on Rules, Laws and Ethics recommends for the passage of a Resolution granting authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to look for available area/site suitable for the location of a fire station preferably at the business/commercial and urban center and to negotiate for the purchase/acquisition and/or expropriation proceedings for a lot not less than five hundred (500) square meters.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant the request for the passage of a corresponding resolution granting authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to look for available area/site suitable for the location of a fire station preferably at the business/commercial district and urban center and to negotiate for the purchase/acquisition and/or expropriation proceedings for a lot not less than five hundred (500) square meters.

On motion of Hon. Raymund P. Guzman and without any objection, CITY RESOLUTION NO. 237-2017 was APPROVED under suspended rules.
