**RESOLUTION ADOPTING AND APPROVING COMMITTEE REPORT NO. 123-2017 ON  
 PROVINCIAL RESOLUTION NO. 2017-9-467 TITLED “RESOLUTION RETURNING  
 ORDINANCE NO. 09-2017 OF THE CITY OF TUGUEGARAO, CAGAYAN”**

**WHEREAS**, Committee Report No. 123-2017 by the Committee on Rules, Laws and Ethics was included in the agenda of the 49<sup>th</sup> Regular Session of the Sangguniang Panlungsod held on July 25, 2017;

**WHEREAS**, during the discussion and deliberation of the said matter, it was suggested to remove the last sentence of the last paragraph of the recommendations;

**WHEREAS**, the Presiding Officer put the matter into votation whether or not to remove the said last sentence;

**WHEREAS**, eight (8) members were not in favor (Hon. Raymund P. Guzman, Hon. Kendrick S. Calubaquib, Hon. Gilbert S. Labang, Hon. Jude T. Bayona, Hon. Grace B. Arago, Hon. Arnel T. Aruga, Hon. Winnoco R. Abraham and Hon. Jose G. Velasco), one (1) member was in favor (Hon. Mary Marjorie P. Martin-Chan), one (1) inhibited (Hon. Maila Rosario T. Que) and one (1) abstained (Hon. Anthony C. Tuddao) from the removal of the last sentence;

**WHEREAS**, another amendment was introduced to the last sentence of the recommendations, that is, to remove the City Legal Officer, to read “*It is further recommended that appropriate criminal/administrative cases shall be filed against the Honorable Members of the Sangguniang Panlalawigan who concurred and affixed their signature in SP Resolution No. 2017-9-467.*”


