**CITY RESOLUTION NO. 242-2017**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND AUTHORIZING THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE NO. 02 REGARDING THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM**

**WHEREAS**, the Department of Social Welfare and Development (DSWD), in its mandate to provide social welfare program particularly through technical assistance and resource augmentation, is providing nutrition services to its clients at the local level through the center-based and community-based services in partnership with non-government organizations under the Program Management Bureau, such as Food for School and Healthy Feeding Program in the day care centers which were previously implemented nutrition programs for the DSWD;

**WHEREAS**, the Supplementary Feeding Program is the provision of food in addition to the regular meals to currently enrolled day care children as part of the DSWD's contribution to the Early Childhood Care Development (ECCD) Program of government;

**WHEREAS**, malnutrition among children is a problem that needs to be addressed by the government, likewise, children who are at risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement to be entered into by and between the Tuguegarao City Government and the Department of Social Welfare and Development Regional Office No. 02 (DSWD RO2), represented by its Regional Director, Ms. Ponciana C. Condoy, for the implementation of the Supplementary Feeding Program.

**RESOLVED FURTHER**, to authorize the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.




