CITY RESOLUTION NO. 243-2017

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. BIENVENIDO C. DE GUZMAN II, TO NEGOTIATE FOR THE PURCHASE OF A LOT FOR THE RELOCATION OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) TUGUEGARAO CITY DISTRICT JAIL-MD (TCDJ-MD) SUBJECT TO EXISTING LAWS AND ACCOUNTING AND AUDITING RULES AND REGULATIONS AND SUBJECT FURTHER TO THE APPROVAL OF THE CITY COUNCIL

WHEREAS, the City Mayor has requested an authority from the Seventh City Council to purchase lot for the relocation of Bureau of Jail Management and Penology (BJMP) Tuguegarao City District Jail – MD (TCDJ-MD) and authority to sign a Memorandum of Agreement pursuant thereto;

WHEREAS, the Committee on Public Safety and Order and Disaster Preparedness, to which the matter was referred, met on July 19, 2017;

WHEREAS, one of the sworn duties of the Tuguegarao City District Jail (TCDJ) is the safekeeping and rehabilitation of inmates;

WHEREAS, pursuant to the said duty and the congestion problem that the Tuguegarao City District Jail (TCDJ) is experiencing, they are in need of Five Thousand (5,000) square meters up to One (1) hectare lot which will be used for their relocation;

WHEREAS, there is a need for the City Government to purchase a lot which will be donated to the Bureau of Jail Management and Penology (BJMP) Tuguegarao City District Jail-MD (TCDJ-MD) to solve the congestion problem in the Tuguegarao City District Jail-MD;

WHEREAS, the Bureau of Jail Management and Penology (BJMP) shall shoulder the construction of the building;

WHEREAS, it was further discussed in the Committee Meeting that subject to the approval of the City Council, the City Mayor will be given the authority to negotiate for the purchase of the said lot on the following conditions: that the lot be suitable for the construction of the District Jail, that it should not be less than One (1) hectare in area and that all pertinent documents should be submitted immediately;

WHEREAS, after a thorough review of the said request, the Committee on Public Safety and Order and Disaster Preparedness recommends for the passage of a Resolution granting authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to negotiate for the purchase/acquisition of lot for the relocation of the Bureau of Jail Management and Penology (BJMP) Tuguegarao City District Jail-MD (TCDJ-MD).

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to negotiate for the purchase of lot for the relocation of the Bureau of Jail Management and Penology (BJMP) Tuguegarao City District Jail-MD (TCDJ-MD) subject to existing laws and accounting and auditing rules and regulations and subject further to the approval of the City Council.

RESOLVE FURTHER, that a copy of this resolution be forwarded to the Bureau of Jail Management and Penology (BJMP) Tuguegarao City District Jail-MD (TCDJ-MD), for their information.


