CITY RESOLUTION NO. 246-2017

RESOLUTION RECOMMENDING THE REVISITING AND UPDATING OF THE CITIZEN'S CHARTER OF TUGUEGARAO CITY

WHEREAS, an Ordinance Institutionalizing the Citizen's Charter of Tuguegarao City was approved on September 2009;

WHEREAS, Section 15 of the ordinance provides that there should be a mandatory annual review and updating of the charter by the Citizen's Charter Task Force composed of all Department Heads;

WHEREAS, there is a need to update and revisit the said Citizen's Charter in order to be attuned to the needs of time;

WHEREAS, after the Committee on Rules, Laws and Ethics discussed and deliberated in a meeting the "*Draft Resolution Recommending the Revisiting and Updating of the Citizen's Charter of Tuguegarao City*" sponsored by Hon. Mary Marjorie P. Martin-Chan, it was recommended that the Citizen's Charter Task Force shall be given three (3) months after the approval of the herein resolution to conduct their review and submit the necessary revision, updates and recommendations to the City Council for proper action;

WHEREAS, during the 51st Regular Session, the Seventh City Council approved the herein resolution finding it to be in order, with merit and beneficial not only to the constituents of Tuguegarao City but also to all the clients of the Tuguegarao City Government;



RESOLVED FURTHER, to furnish a copy of this resolution to the City Mayor, Hon. Bienvenido C. De Guzman II, for proper action.


