CITY RESOLUTION NO. 248-2017

RESOLUTION AUTHORIZING THE INCUMBENT LOCAL CHIEF EXECUTIVE OF TUGUEGARAO CITY, CAGAYAN TO ENTER FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE LOAN AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) TO FINANCE ITS APPROVED PROJECTS AMOUNTING TO ONE HUNDRED TWENTY MILLION PESOS (P120,000,000.00)

WHEREAS, the Tuguegarao City Government desires to avail of a loan with the Development Bank of the Philippines (DBP) to finance its priority Programs, Projects and Activities (PPAs);

WHEREAS, City Resolution No. 214-2017 titled "*Resolution Authorizing the Incumbent City Mayor to Negotiate for the Best Terms to Obtain the Omnibus Loan Facility*" was approved by the Seventh City Council during its Special Session on June 22, 2017;

WHEREAS, the incumbent City Mayor, through its Negotiating Committee, considered two (2) government banks which signified intention to extend credit facility to the City Government;

WHEREAS, the Negotiating Committee had chosen the Development Bank of the Philippines (DBP) having offered a low interest, a greater number of grace period and considering that it is the depository bank of Tuguegarao City Government;

WHEREAS, the incumbent City Mayor through a letter dated July 25, 2017 to the Seventh City Council requested for an authority to enter for and on behalf of the Tuguegarao City Government the loan contract with the Development Bank of the Philippines (DBP);

WHEREAS, pursuant to Committee Report No. 139-2017 of the Committee of the Whole, duly approved and adopted in plenary, the Committee favorably recommended the passage of the herein resolution authorizing the incumbent Local Chief Executive of Tuguegarao City, Cagayan to enter for and on behalf of the Tuguegarao City Government the loan contract with the Development Bank of the

Philippines (DBP) to finance its approved projects amounting to One Hundred Twenty Million Pesos (P120,000,000.00);

WHEREAS, in order to facilitate the transaction with the said bank, there is a need to authorize the incumbent Local Chief Executive to enter into a local contract and to authorize him to transact business with the Development Bank of the Philippines (DBP).

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to authorize the incumbent Local Chief Executive of Tuguegarao City, Cagayan to enter for and on behalf of the Tuguegarao City Government the loan agreement with the Development Bank of the Philippines (DBP) to finance the approved projects below amounting to One Hundred Twenty Million Pesos (P120,000,000.00), subject to the approval of the Sangguniang Panlungsod of Tuguegarao City:


