**CITY RESOLUTION NO. 251-2017**

**RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – LAND MANAGEMENT BUREAU, REGIONAL OFFICE NO. 02 (DENR-LMB R02) TO CONDUCT SURVEY AND MAPPING OF HOME STRETCHES LOCATED ALONG TERESITA BOULEVARD AND PINACANAUAN RIVERBANK AND TO SUBMIT A CERTIFICATION DECLARING THE AREA AS INALIENABLE PUBLIC LAND RESERVED AS OPEN SPACES**

**WHEREAS**, the City Mayor, Hon. Bienvenido C. De Guzman II, has written a letter to the Seventh City Council requesting for the declaration of the area between Teresita Boulevard and Pinacanauan Riverbank at Centro 09 up to Barangay Tanza as inalienable public land reserved as open spaces;

**WHEREAS**, the said indorsement has been referred to the Committee on Climate Change, Environmental Protection and Ecology and Committee on Rules, Laws and Ethics which convened in a meeting on June 14, 2017 and July 26, 2017 for the said purpose;

**WHEREAS**, the joint committees found that the area located between Teresita Boulevard and the Pinacanauan Riverbank at Centro 09 up to Barangay Tanza is classified as agricultural land and that there is a need to preserve the area to promote and protect the environment against climate change, pollution and for recreational purposes, hence, the declaration of the area as inalienable public land reserved as open space is necessary.

**NOW, THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to request the Department of Environment and Natural Resources – Land Management Bureau, Regional Office No. 02 (DENR-LMB R02) to conduct survey and mapping of home stretches located along the Teresita Boulevard and Pinacanauan Riverbank and to submit a certification declaring the area as inalienable public land reserved as open spaces.




