PAGURAYAN, TO APPEAR FOR AND REPRESENT THE TUGUEGARAO CITY GOVERNMENT IN CIVIL CASE NO. 8606 TITLED SIERRA MADRE VAN OPERATORS AND DRIVERS' ASSOCIATION, INC. (SMAVODA) REPRESENTED BY DOMINADOR G. ORPILLA, GATTARAN CENTRO VAN OPERATORS AND DRIVERS' ASSOCIATION, INC. (GCVODA), REPRESENTED BY JOSELITO P. DELA CRUZ, NORTHLANDIA TRANSPORT GROUP ASSOCIATION, INC. REPRESENTED BY JOHN T. DUMAYAG, PENDING BEFORE THE REGIONAL TRIAL COURT, BRANCH 5, TUGUEGARAO CITY.

Joana May C. Pagurayan are hereby authorized to represent the Tuguegarao City Government in Civil Case No. 8606 titled *Sierra Madre Van Operators and Drivers' Association, Inc. (SMAVODA)* represented by *Dominador G. Orpilla*, *Gattaran Centro Van Operators and Drivers' Association, Inc. (GCVODA)*, represented by *Joselito P. Dela Cruz*, *Northlandia Transport Group Association, Inc.* represented by *John T. Dumayag* pending before the Regional Trial Court, Branch 5, Tuguegarao City;

WHEREAS, Atty. Raymund P. Guzman, Atty. Romeo I. Calubaquib, Atty. Louie Bernard A. Aquino and Atty. Joana May C. Pagurayan are also authorized to represent the Tuguegarao City Government in all stages of the proceedings like mediation, preliminary conference, pre-trial to discuss

the matters stated in Section 2, Rule 18 of the Rules on Civil Procedure, trial by presenting evidence in its behalf and appeal for the review in Civil Case No. 8606 titled *Sierra Madre Van Operators and Drivers' Association, Inc. (SMAVODA) represented by Dominador G. Orpilla, Gattaran Centro Van Operators and Drivers' Association, Inc. (GCVODA), represented by Joselito P. Dela Cruz, Northlandia Transport Group Association, Inc. represented by John T. Dumayag* pending before the Regional Trial Court, Branch 5, Tuguegarao City;

WHEREAS, Atty. Raymund P. Guzman, Atty. Romeo I. Calubaquib, Atty. Louie Bernard A. Aquino and Atty. Joana May C. 
