**CITY RESOLUTION NO. 254-2017**

**A RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT RO2 (DOLE-RO2) FOR THE IMPLEMENTATION OF THE JOBSTART PHILIPPINES PROGRAM AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF UNDERSTANDING**

**WHEREAS**, the Referral which is “Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Understanding with the Department of Labor and Employment RO2 (DOLE RO2) for the implementation of the JobStart Philippines Program” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee, to which the matter was referred to, met on August 29, 2017 to discuss the subject referral;

**WHEREAS**, the JobStart Philippines is a flagship program of the Department of Labor and Employment (DOLE) being implemented with technical assistance from the Government of Canada and Asian Development Bank (ADB);

**WHEREAS**, the program aims to shorten the youth’s school to work transition with the participation of the private sector and other stakeholders;

**WHEREAS**, Local Government Units through the PESOs shall serve as the main partners of the DOLE in implementing the program at the local level;

**WHEREAS**, upon review of the Memorandum of Understanding, the Committee on Rules, Laws and Ethics recommends for the adoption and approval of the Memorandum of Understanding and a Resolution granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City the said Memorandum of Understanding with the Department of Labor and Employment RO2 (DOLE RO2).

**NOW, THEREFORE RESOLVE**, as it is hereby **RESOLVED**, to grant the request for the approval of the Memorandum of Understanding and the passage of a corresponding Resoution granting authority to the City Mayor, Hon. Bienvenido C. De Guzman II, to sign for and on behalf of the City Government the Memorandum of Understanding with the Department of Labor and Employment RO2 (DOLE RO2) for the implementation of the JobStart Philippines Program.


